**Introduction**

Staff has invited Heather Worthington, Deputy Ramsey County Manager and Jonathan Weinhagen from the Saint Paul Chamber to present findings on their work to the City Council. They will present independently with information that describes the economic, demographic, income and education statistics of Ramsey County and Maplewood. This presentation will provide very useful information as we move forward with our vision and planning for the City of Maplewood.

**Background**

The department heads and City Manager heard the Ramsey County presentation on Economic Prosperity a few months ago and we believe that the information tells a compelling story about the economic needs and challenges in the county and our place in the metropolitan area. Additionally, City Manager Ahl and I met with Matt Kramer and Jonathan Weinhagen from the Saint Paul Chamber to discuss employment demographics and to hear about their business assessment of Maplewood. Their findings and statistics were very telling.
